A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CARMEL-BY-THE-SEA DECLARING THE RESULTS OF THE GENERAL MUNICIPAL ELECTION HELD IN THE CITY OF CARMEL-BY-THE-SEA ON NOVEMBER 8, 2022

WHEREAS, on June 6, 2022 the City Council adopted Resolution 2022-043 calling for the holding of a Municipal Election for the purpose of electing a Mayor for a full term of two-years and two Council Members for full-terms of four-years; and

WHEREAS, Resolution 2022-043 requested the County Elections Department to conduct the Election, requested consolidation of the Election and provided a procedure for determining a tie for the November 8, 2022 General Municipal Election; and

WHEREAS, the Monterey County Elections Department canvassed the returns of the election, has provided the results and those results are hereby attached and made a part hereof as Exhibit A.

## NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CARMEL-BY-THE-SEA:

All absentee and provisional ballots have been duly received and canvassed in the time, form and manner as required by Law.

The whole number of votes cast in said election was 1,956 as follows:

Jeff Baron and Alisssandra Dramov are hereby elected to the office of City Council Member each for a four-year term.

The City Clerk is instructed to issue a Certificate of Election to Dave Potter, Jeff Baron and Alissandra Dramov and administer the Oath of Office to each elected person and shall have them subscribe to it and file it in the Office of the City Clerk.

The City Clerk is instructed to enter into the records of this City Council this Resolution as a statement of the result of said election.
