### PLEDGE OF ALLEGIANCE

Members of the audience joined the Commission in the Pledge of Allegiance.

### **APPEARANCES**

Greg D'Ambrosio wanted to be sure the two newest commissioners had received copies of the Friends of Mission trail Nature Preserve "Blue Book". He noted that copies are available from copies by the Sea and that Public Works Superintendant Stu Ross should also look at the document.

### **CONSENT AGENDA**



1. Consideration of the minutes for the 11 December 2014 regular meeting.

Chairperson Refuerzo identified a correction on page 3 – Chairperson Baron should be Commissioner Baron.

It was moved by FERLITO to approve the minutes for the 13 November 2014 regular meeting, as corrected; seconded by BANG.

The motion carried by the following vote:

### **ORDERS OD BUSINESS**

2. Provide suggestions to the Community Services Director regarding special event permits on Carmel Beach.

Janet Bombard, Library and Community Services Director, presented a report on the Community Activities Department and the City special event permit process. She noted that the City is going to evaluate the permitting process for events with some thoughts on lowering the attendance threshold for a permit, limiting the number of attendee's, limiting the number of events, and basing the events on the available facilities for each event. She also pointed out that the California coastal Commission has expressed some concerns about events on Carmel Beach.

Commissioner Ferlito asked who inspects after events and how timely is an inspection.

Director Bombard responded that she and her assistant Ashley Wright do inspections as they can, but here is a need for a beach patrol.

Commissioner Ferlito asked about large vehicles and porta-potties for events.

Director bombard answered that those are not allowed.

Commissioner bang asked if amplified music is allowed.

Director Bombard answered yes and no. It is allowed but cannot be heard outside of a 25' radius.

Commissioner Bang asked if events are supposed to bring their own trash cans or can they use the city receptacles.



Director Bombard answered that permitted events are not supposed to use city receptacles, but it does happen. Permitted events are required to submit a trash plan for their event.

Chairperson Refuerzo asked about dumpsters for events.

Director Bombard answered that dumpsters are not allowed for events, but the City places them for holiday weekends.

Commissioner Bang asked about excluding the public from areas on the beach.

Director Bombard responded that events are not allowed to section off a private area. Applicants are verbally told this, but it does happen.

Commissioner Baron asked who gets a permit for an event. Odes a caterer, the event planner, or host get the permit.

Director Bombard pointed out that it depends on the type of event, but it can be the caterer or a planner or the host.

Commissioner Baron asked about events taking over large areas early in the day for events that do not start until the evening.

Director Bombard noted that does occur.

Commissioner Carter asked if events are restricted to certain areas of the beach.

Director Bombard answered no, but no more permits will be issued in the North Dunes since it is an environmentally sensitive habitat. Most beach events use the 13<sup>th</sup> Ave. cove.

Public comment opened at 3:56 p.m.

Greg D'Ambrosio commended the Commission for tackling two tough beach items – special events and beach fires. He has two areas of concern: events taking up space and telling others to keep out, and policing of beach fires. He recommends asking the City Council for a full-time beach ranger to work on weekends and afternoons and evenings.

Gary Girard asked if the 13<sup>th</sup> Ave. cove could be pre-arranged as to what areas are to be used by events.

Skip Lloyd commended Director Bombard for her report and he thought that events should go hand-in-hand with beach fires and enforcement needs.

Scott McKenzie thought the efforts are to pile on rules and have the police enforce. Asked how many complaints have been received. He pointed out that there is a need to figure out what the problems are and don't fix problems that do not exist. If there are problems then set goals and objectives to solve them.



Public comment closed at 4:02 p.m.

Commissioner Bang thanked Director Bombard for addressing the event issues. She commented that all of her concerns seem to be addressed including getting Coastal Commission input. She thought that perhaps event should be restricted to only propane fires on the beach.

Chairperson Refuerzo also thought events should use propane for fires.

Commissioner Ferlito is concerned about large tucks and restrooms for events. She commented that pig roasts, generators, and balloons should be banned. She also has seen companies using the city trash receptacles and she does not like companies using the beach in their advertisements. She also thought there is a need for inspections after events and a need to allow public use of the beach. She reported that the State beaches require permits for more than 25 participants and all events. She thought the City needed to tighten up it's processes.

Commissioner Baron agreed with Commissioner Ferlito that procedures need to be tightened. He thought that groups should be able to use the city fire rings and restricting the space and lowering the number of events is a good idea. He also thought enforcement should begin when the set up for an event begins, not when it is scheduled to begin.

Commissioner Bang noted it would be good to know how the Planning Commission addresses commercial activity.

Commissioner Baron noted that who get the permit may affect how events are dealt with by staff.

Chairperson Refuerzo asked about the fees charged for events.

Director Bombard reviewed the fee structure for events.

Public comment re-opened at 4:14 p.m.

Greg D'Ambrosio thought that caterers and hosts should both apply for a permit so they would both know the rules and conditions of the event.

3. Receive and discuss beach fire management recommendations from the ad hoc Beach Fires Committee and provide recommendations to the Planning Commission.

Commissioner Bang presented the beach fire management recommendations of the ad hoc beach fire committee:

- 1. 26 wood burning fire pits of an appropriate size to be placed on the beach -2 at each stairway and 4 in each cove.
- 2. Only burn dry seasoned firewood no driftwood, pallets, or other materials.
- 3. City owned and placed and anchored by the City.
- 4. Cleaned daily.
- 5. First come first served. No permits at this time.



- 6. Allow unlimited user supplied propane fires year round south of 10<sup>th</sup> Ave.
- 7. Fire pits will be provided seasonally and removed in winter based on beach conditions.
- 8. City to provide enhanced security patrols 5 days a week until 11:00 p.m.
- 9. For pilot program a variety of fire pits will be tried. After pilot program a Carmel design should be developed.
- 10. For summer holiday weekends the City will provide 25 additional portable fire baskets per day. These will be left on the beach for pickup the following day by the City.
- 11. Develop a public education program on the new fire rules and procedures.
- 12. Monitor the program and recommend changes as issues arise.

Commissioner Ferlito asked about allowing charcoal in addition to seasoned wood.

Commissioner Bang thought that should be allowed.

Commissioner Baron asked about the proposed placement of the fire pits and expressed concern that some homes may get more smoke than others. Perhaps an even spacing would even out the smoke exposure to the homes.

Branson explained how the fire pit placement was developed.

Commissioner Bang pointed out that the placement is where most people seem to want their fires and adjustments can be made as the program is implemented.

Commissioner Carter pointed out that Memorial Day would be a good first test and some things could be reassessed after the holiday weekend.

Public comment opened at 4:29 p.m.

Greg D'Ambrosio thought that if the City goes forward with the program, all of the recommendations need to be implemented in order to provide a true picture of the program's success or deficiencies. This is a long term problem and he is opposed to wood fires and thought that "fires in a can" should only be allowed. He noted that the City once purchased and provided low-flush toilets to residents and hotels. Perhaps the City could do the same thing with portable propane fires. This would eliminate most of the beach fire issues as well as the costs that will be incurred to manage the fire program.

Commissioner Bang noted that the winter season should give a good representation of how propane fires will work on the beach.

Skip Lloyd appreciated the work of the ad hoc committee and the Commission on the fire issues. He expressed disapproval of the installation of permanent fire pits and thinks they will be ugly. He also does not like dedicating the cove areas for fire as this will preclude the non-fire use of the coves. He agrees that signage and enforcement need to be in place for the program to succeed. He is in favor of having the fire baskets available with cleanup the next day.

Scott McKenzie thought that oil burning tiki torches, pig roasts, and generators should not be allowed on the beach. He pointed out that smoke cannot be fair to everyone. He thought that 26 fire pits would result in some people being turned away from the beach. Enforcement of the



wood requirement, not to burn trash, and people holding places will be difficult. He pointed out that his proposal will solve most of the fire issues. He asked if catered food is allowed, why not catered fires?

Public comment closed at 4:42 p.m.

Commissioner Baron thanked the committee for their work. He thought that fire pits will be dirty and there may be fights over them, but the City needs to do something. He noted that that the City needs to be committed to regular cleaning of the fire pits. He would like to also allow free, permitted portable charcoal fires allowed on the beach. Permits would be issued at the police Department along with the rule on fires and charcoal disposal. Perhaps they could also be allowed in winter. He understands that this idea may not work, but as a trial, as part of the pilot program it should be considered.

Commissioner Bang asked for clarification of commissioner Baron's proposal.

Commissioner Baron clarified his request.

Commissioner Ferlito thought that adding additional items to the original proposal may dilute the effectiveness of evaluating the program.

Commissioner FERLITO moved to adopt the recommendations of the ad hoc committee with the addition of allowing charcoal in the fire pits and a strong recommendation for an enhanced staff patrol of the beach; seconded by Commissioner CARTER.

Chair Refuerzo asked if charcoal grills were being banned. Forester Branson noted that portable charcoal grills are considered fires.

Commissioner Baron wanted the issue of portable charcoal grills should be discussed now as to whether to allow them or not. He did not think that allowing charcoal grills would affect the original proposal and the City needs to try allowing them to see if it works or not.

Commissioner Bang pointed out that this is the first time she recalls discussing charcoal grills. She noted that a limited number allowed by permit could be allowed, but an unlimited number is not a good idea.

Commissioner Baron pointed out that permits that would be issued by the police Department would include all of the fire rules. He thinks that five per day is a reasonable number to try.

Commissioner Ferlito expressed concern that the charcoal grill proposal complicated the issues and a pilot program should have a clear message – fires in fire pits only.

Commissioner Baron pointed out that people may dump their charcoal in the trash or on the beach, but we won't know unless we give the idea a try.

Commissioner Bang thought that the original proposals should be implemented and the issue of charcoal grills can be considered later.



Commissioner Ferlito expressed her concern that charcoal will be dumped on the sand and the checking of permits will be additional work for the security patrols.

Chair Refuerzo asked Commissioner Ferlito if she was willing to amend her motion to allow a limited number of permitted charcoal grills.

Commissioner Ferlito declined to amend her motion.

Chair REFUERZO presented a substitute motion to adopt the recommendations of the ad hoc committee, allow charcoal use in the fire pits, a strong recommendation for an enhanced staff patrol of the beach, and allow 5 free, permitted portable contained charcoal cooking fires per day with fire rules provided at the issuance of the permit by the Police Department. Seconded by BARON

4. Review of the design for the Mission Trail Nature Preserve entrance at Mt. View Ave. and provide recommendations to the Planning Commission.

Branson outlined the proposal and the role of the Commission in the approval process.

Beth Matz from Bellinger, Foster, Steinmetz Landscape Architects, presented the materials to be used, reviewed the scope of work, and discussed how the existing site issues have been addressed by the new plan.

Commissioner Bang asked about police access at this entry to Mission Trail Nature Preserve.

Branson answered that the police motorcycle officer occasionally uses the Mt. View entrance for quick access into the Preserve.

Commissioner Baron asked if the Commission decided whether to have stairs and a ramp.

Branson noted that people pushing strollers, bicycles, and runners may prefer a ramp rather than stairs.

Commissioner Baron asked if the concrete surface will have enough texture to limit slipping.

Branson answered that staff and the landscape architect looked at alternative surfaces for the ramp before deciding on the colored concrete with heavy tooling.



Commissioner Bang asked if the Friends of Mission Trail Nature Preserve (FOMTNP) were supportive of the proposed plan.

Beth Metz told the Commission that she has met with the FOMTNP board and has included some of their comments into the proposed design.

Public comment opened at 5:35 p.m.

Skip Lloyd, FOMTNP President, reviewed the role of the FOMTNP and outlined their input into the design of the entry project. He hoped that there will be sufficient funding to complete the project. He also noted that the FOMTNP may be able help with fundraising and that Bill Doolittle, who donated much of the Preserve property, is supportive of the entry project.

Greg D'Ambrosio noted that this project is a critical project for the success of the FOMTNP efforts in the Preserve. He pointed out that having two routes at the entry will solve the problem of sediment eroding onto the bridge. Attention needs to be paid to the grade break at the top of the slope to prevent as much water as possible from going down slope. He thought a cupped ramp could be considered to help divert any water away from the bridge. He liked the brushed finish on the concrete to help direct water and provide traction. He also noted that he has spoken about the drainage issues with the Public Works Superintendant and the use of a larger diameter pipe coming out of the bioswale is recommended. HE asked the landscape architect to also contact the Public Works Supervisor about the drainage issues.

Commissioner Baron asked how wide the concrete pad is.

Beth Matz answered that the path is 5 feet long and 100 feet long.

Skip Lloyd noted that getting this project to the Planning Commission for their approval is important to having this project completed in the current fiscal year.

Public comment closed at 5:45 p.m.

It was moved by BANG to approve the minutes design for the Mt. View entrance to MTNP, to have the Public Works Superintendant discuss he drainage issues with the landscape architect, and forward the project to the Planning Commission; seconded by FERLITO.

Commissioner Baron expressed some concerns about the multiple materials being introduced into a small area of the Preserve with the proposed design. He likes the simple, peaceful entrance feel that is there now and thought the new elements may ruin the simple feel.

Branson pointed out that many of the materials are found currently at the existing entrance and elsewhere within the Preserve.

Commissioner Ferlito thought the FOMTNP would not support the project if the materials were not fully considered for effectiveness and aesthetics.

Public comment reopened at 6:07 p.m.



Greg D'Ambrosio pointed out that concrete is found elsewhere in the Preserve and safety is a key issue.

Public comment closed at 6:08 p.m.

Chairperson Refuerzo agreed with Commissioner Ferlito that this is not an attractive or effective entry now and the Planning commission can make the final decision on the 4 material used.

The motion carried by the following vote:

 Review and provide recommendations to the Planning Commission on a proposal for a new signage template for Mission Trail Nature Preserve developed by the Friends of Mission Trail Nature Preserve.

Branson presented his staff report on the proposal to change the entry sign to MTNP.

Commissioner Baron asked if the proposal is for one entrance or all of the entrances.

Branson answered that all of the entrances are proposed to be changed.

Greg D'Ambrosio from the FOMTNP, provided an explanation of the materials to be used for the signs and gave a Powerpoint presentation on the proposed sign design and the proposed new locations for the signs at each entry point.

Commissioner Bang asked if the City sign consultant was involved in this project.

Sharon Friedrichsen answered that the sign consultant is not involved in this project.

Commissioner Baron asked if the signs have already been approved and the mounting design and locations are the only issues for consideration.

Branson answered that the signs area approved and the only items for consideration are the mounting design and locations.

Public comment opened and closed at 6:20 p.m.

It was moved by REFUERZO to approve the signage proposal for MTNP and to forward the proposal to the Planning Commission; seconded by CARTER.

6. Consideration of the regular meeting calendar for 2015.

Branson presented the 2015 meeting calendar. He noted that February date is a city holiday and needed to be moved or cancelled.

Chairperson Refuerzo noted that the August date co-insides with the Thursday car week event. He suggested moving the February date to the 19<sup>th</sup>.

By a unanimous voice vote the Commission approved changing the February 12<sup>th</sup> meeting date to February 19<sup>th</sup>.

Commissioner Baron suggested addressing the August meeting date now.

Chairperson Refuerzo suggested moving the August date to August 20<sup>th</sup>.

By a unanimous voice vote the Commission approved changing the August 13<sup>th</sup> meeting date to August 20<sup>th</sup>.

### REPORTS FROM STAFF AND COMMISSIONERS

### 10. Forester's report

Branson reported on the trees lost so far in the storm today and reviewed the tree data for October and November.

Commissioner Ferlito asked how the tree tagging program was going.

Commissioner Ferlito noted that over 100 stumps have been removed.

Branson provided information on the stump removal program that is underway.

Commissioner Ferlito asked about a stump on private property on San Carlos St.

Branson noted that the owner wanted to leave the stump as it is.

Commissioner Bang asked about planting where the stumps are being removed.

Branson noted that more planting is pending and that watering hours have been increased. He also pointed out that the is a large carryover of trees planted last year that still need to be watered due to the drought.



Branson reported that the New Scenic pathway restrooms opened today.

Sharon Friedrichsen provided additional details on the status of the restroom project and what remains to be completed.

Commissioner Ferlito suggested using the inside of the doors for a beach rules sign.

Branson reported that the FOMTNP have been working in the Preserve.

Commissioner Ferlito asked if Commissioners Baron and Carter have received the FOMTNP blue book.

Commissioner Carter said he has a copy.

Branson said Commissioner Baron should have a copy but if he does not, the City will provide one to him.

Branson reported that David Shonman has started shoreline assessments and an engineer has been contacted to examine the seawalls and revetments.

Commissioner Ferlito asked about the cigarette butt collection program.

Sharon Friedrichsen reported that the Planning Commission reviewed the cigarette butt collection program yesterday and they did not like any of the suggested options. The Commission wants the City to look into finding something that coordinates with the current sidewalk trashcans.

Commissioner Ferlito reported that the City Council held a workshop on prioritizing projects and that beautification and implementation of the Shoreline and Forest master Plans were near the top of the rankings.

Commissioner Ferlito reported on the Arbor Day event.

Currently fires are allowed on the beach south of Tenth Ave. and they have to be in compliance with several fire management rules. The water is currently being captured to a central point adjacent to the parking lot. Electrical conduit is also in place to support the electric needs of the pump system
