CHALLENGING DECISIONS OF CITY ENTITIES The time limit within which to commence any lawsuit or legal challenge to any quasi-adjudicative decision made by the City of Carmel-by-the-Sea is governed by Section 1094.6 of the Code of Civil Procedure, unless a shorter limitation period is specified by any other provision, including without limitation Government Code section 65009 applicable to many land use and zoning decisions, Government Code section 66499.37 applicable to the Subdivision Map Act, and Public Resources Code section 21167 applicable to the California Environmental Quality Act (CEQA). Under Section 1094.6, any lawsuit or legal challenge to any quasi-adjudicative decision made by the City must be filed no later than the 90th day following the date on which such decision becomes final. Any lawsuit or legal challenge, which is not filed within that 90-day period, will be barred. Government Code section 65009 and 66499.37, and Public Resources Code section 21167, impose shorter limitations periods and requirements, including timely service in addition to filing. If a person wishes to challenge the above actions in court, they may be limited to raising only those issues they or someone else raised at the meeting described in this notice, or in written correspondence delivered to the City of Carmelby-the-Sea, at or prior to the meeting. In addition, judicial challenge may be limited or barred where the interested party has not sought and exhausted all available administrative remedies.

2. Report from the 2017 Arbor Day event committee.

Assistant City Forester Matt Feisthamel announced that he had called local nurseries to find what trees would be available for a 1 gallon tree give away and the committee is still working on ideas.

Commissioner Massoudi announced that a meeting was being scheduled with all those involved to discuss and plan the event and once that is completed they will present to the Commission.

Commissioner Ferlito announced that she would like to see a "visual" spruce up of an area similar to last year's First Murphy House project. Would also like a tour of the area being considered at Forest Hill Park to be added as a tour on a future agenda.

3. Report on options for tree inventory data collection.

Assistant City Forester Matt Feisthamel announced that a software program has been leased for review. Would like to find a product that integrates with current tree survey; looking into using current IWorq software; would like a program that shows trends of tree care, replacement trees, tracking for 5-year requirement and plotting of the downtown area.

SUBJECT: Beach fire pilot program update and recommendations to the City Council

#### RECOMMENDATION

Discuss the beach fire pilot program and provide recommendations on any changes to the City Council.

#### BACKGROUND / SUMMARY

The City of Carmel initiated a pilot program for management of fires on Carmel Beach in the spring of 2016. The three year program is intended to restrict the number of wood fires on the beach and not allow any fires directly on the sand. The following are the core requirements for having beach fires:

- Wood fires only allowed in City provided fire pits seven days a week.
- Wood fires must be 75 feet away from the base of the beach bluffs and a minimum of 200 feet apart.
- A maximum of 12 wood fire pits can be placed between Eighth and the south end of the beach.
- Only burn clean firewood no charcoal briquettes, other wood debris or trash.
- An unlimited number of propane fires allowed but must be 25 feet away from the base of the beach bluffs.
- All fires must be south of Eighth Avenue.
- Fires only allowed between 4:00 p.m. and 10:00 p.m.
- Fires pits are available on a first come, first serve basis; communal sharing is recommended.
- No reservations except with a special event permit.

#### 2016 Season

During the 2016 beach fire pilot program the City first installed two fires pits on July 7th, 2016. Two additional fire pits (total of 4) were installed on July 26th, 2016.

For the 2016 season temporary laminated paper signs were place at all beach access points to provide visitors the pertinent fire rules in place at any given time.

The City received a letter from the Monterey Bay Air Resources District on July 28, 2016. The letter informed the City the fires constituted a public nuisance because of the poor air quality from the nearby Soberanes Fire. The fire program was suspended at this time.

On September 6, 2016, the Monterey Bay Air Resources District lifted the no-burn order. The City installed 2 more fire devices (total of 6) on September 8, 2016.

On November 2, 2016 the Public Works staff removed all six wood fire devices off the beach for the winter season.

#### 2017 Season

As Carmel Beach recovered from heavy winter scouring of the beach area, one fire pit was placed at Eighth Avenue in Mid-May. As the beach continued to recover and the available sand area grew, two more pits were placed between Tenth and Eleventh Avenues in late May. Six more pits were placed from Tenth to Thirteenth Avenues in early June for a total of nine City provided wood fire pits as of July 1, 2017.

The City installed new, metal beach fire rule signs at all beach access points for the 2017 season. These signs can be modified if there are changes to the fire rules. The City web site is also a resource for the current beach rules.

#### **Experiences and Issues**

Fires on Carmel Beach continue to very popular with beach visitors – locals and tourists. Staff receive several phone calls a day asking for fire information. Currently City staff are responsible for the weekday cleaning and monitoring of the City fire pits as well as cleaning up any illegal fires along the entire beach. Some of the issues faced by Public Works staff are:

- Trash discarded into and trash burned in the fire pits.
- Filling the fire pits with sand either to extinguish a fire or creates a flat surface for building a fire.
- Moving the fire pits from their approved location.
- Burying the lids in the sand.
- Excess amounts of water dumped on the fires.
- Illegal fires on the sand in both the allowed fire area and other areas of Carmel Beach.
- Burning driftwood, charcoal briquettes, and commercial fire logs.
- Periodic high tides reaching the fire pits.

Staff will provide a short Powerpoint presentation on some of these issues at the meeting.

#### **Discussion Items**

The Forest and Beach Commission has been asked to provide comments and recommendations to the City Council regarding any changes to the pilot program. The Council is scheduled to receive a report on the pilot program in September and may make adjustment to the program for the 2018 season.

The Commission should review and discuss the core requirements of the pilot program and forward any suggested modifications to the City Council for their consideration. Additionally, suggestions and recommendation on other elements of the fire program such as enforcement, signage, public outreach, cleanup, user surveys, fire pit design, etc. should also be forwarded to the City Council.

#### BACKGROUND / SUMMARY

Chair Refuerzo appointed Commissioners Massoudi and Saroyan to an ad hoc committee to work with staff on the 2017 Arbor Day program. Arbor Day updates will be a regular agenda item for the entire Commission to provide input on the recommendations from the ad hoc committee.

An outline of the latest committee discussions are attached for review and comment by the Commission.

The City of Carmel does not have an officially designated "Arbor Day". A day to recognize and promote the value of trees to the community fulfills a duty and responsibility of the Forest and Beach Commission, as well as, meeting one of the requirements for designation as a Tree City USA.

# City of Carmel by-the-Sea Arbor Day Event Ad-Hoc Committee Meeting June 28th, 2017.

Mo Massoudi, Mike Branson and Matt Feisthamel met at Forest Hill Park at 3:30PM on June 28th to discuss plans for the upcoming Arbor Day event celebration. During the meeting they discussed the following items:

#### Time and Date:

The proposed event date is planned for September or October of 2017, the exact day of the event is to be discussed and selected by the F&B Commission. The date should not conflict with any other ongoing or pre-scheduled local events. The proposed time is from 10:00AM to 1:00PM.

#### **Arbor Day Theme:**

The committee suggested inviting and coordinating with the Friends of Carmel Forest group, the group may become a co-sponsor for the Arbor Day event. We also suggested inviting the Mayor, City Council and business members to the event. The committee suggested contacting the Principals of Carmel River School and Carmel Middle School for the potential participation of the students.

#### **Planting Trees:**

Within Forest Hill Park, many trees have been removed throughout the years, it is the plan of the Arbor Day event to replace some of the trees that have been lost. The committee suggested planting native shrubs, oak trees and pine trees. The exact number of trees and shrubs to be planted at the event can be discussed with the commission. It was noted high voltage power lines occur in the park and tall trees should not be planted under the lines.

The City can provide wood chips, amended soil and planting tools for the event. It might be helpful to have some of the planting holes dug by City staff before the event date. The public will be invited to participate in the planting.

#### Music:

The committee suggested having a live band play during the event. Mike and Mo have some band contacts and they will report back to the F&B Commission. If a band cannot be scheduled, the City has a sound system that can be used.

#### **Advertisment:**

The City of Carmel by-the-Sea will post the Arbor Day event on the City website. It was also suggested to place an ad in the Carmel Pine Cone newspaper. Another idea is to create a City Carmel by-the-Sea Arbor Day event poster and distribute it to various merchants in town.

#### Food:

The committee suggested catering food to draw the public to this event. Mo suggested bringing in a food truck to the event to serve people, the food truck option will require some more research to see if it is cost effective or allowed within City regulations.

#### Setup:

The City will provide shovels, rakes, mulch, wood chips and the shrubs/trees. The City can also help with the set up the tables, table cloths, chairs and trash cans. The volunteers at the event can help with the cleanup and the planting of the trees.
