#### **PLEDGE OF ALLEGIANCE**

Members of the audience joined the Commission in a moment of silence in memory of the 9/11 event and in the Pledge of Allegiance.

#### **APPEARANCES**

Barbara Livingston, representing the Carmel Residents Association, presented the Commission with a copy of the latest CRA newsletter that contains several sections of the Carmel 2016 Committee report from 1991 and an analysis of those sections by current community members.



She also requested that the Commission ask the City Council to fund removing stumps and planting new trees prior to the City centennial in 2016.

#### **CONSENT AGENDA**

1. Consideration of the minutes for the 28 August 2014 regular meeting.

Commissioner Ferlito identified a couple of typographical errors.

It was moved by BANG to approve the minutes for the 28 August 2014 regular meeting, with the typographic corrections; seconded by FERLITO.

#### **APPLICATIONS / PUBLIC HEARINGS**

2. Consideration of an application to remove one Monterey pine (40" diameter) on private property due to the age of the tree and safety concerns. The site is located on Santa Fe St., 4 houses southwest of 8th Ave. The applicant is Andrea Spungen.

Forester Branson presented his staff report and answered questions from the Commission.

Public comment opened at 3:55 p.m.

Matt Raggio, representing the applicant, asked about liability if the tree fails. He also expressed that the applicant is trying to anticipate future problems and asked what happens in the future if problems arise.

Public comment closed at 4:00 p.m.

Forester Branson provided guidance on both questions.

After further discussion of the tree and the condition of the remaining trees, Commissioner BANG made a motion to follow the Forester's recommendation to retain the tree; seconded by FERLITO.

#### **ORDERS OF BUSINESS**

3. Receive and discuss a report from the ad hoc Beach Fires Committee.

Commissioner Bang reported on the activities of the ad hoc Committee. She informed the Commission on the details of the ad hoc committee's meetings with Scott McKenzie of CarmelNatur to receive his input on the analysis of the beach fire issues and that Commissioner Carter had completed a web search of fire rules from other coastal states around the country. Meeting with a representative from the Monterey Bay Unified Air Pollution Control District is scheduled for next week and meeting with a California Coastal Commission representative is still pending.

Commissioner Carter reviewed the data he assimilated on beach fire rules.

Commissioner Baron asked if portable fires, such as charcoal or gas grills, will be allowed and if the air quality has been, or will be, measured.

Commissioner Bang answered that allowing other types of fires still needs to be determined and hopefully the meeting with the Air District will provide some guidance on measuring air quality.

Commissioner Baron asked how permits are issued in other states.

Commissioner Carter responded that permits vary. They are issued online, by fire departments, police departments, and some require deposits. There is no uniformity in how they are issued.

Commissioner Refuerzo asked if the Pebble Beach Co. had been contacted regarding their beach fire policy and procedures.

Commissioner Bang responded they had not, but will check with the Pebble Beach Co.

Public comments opened at 4:22 p.m.

Maggie Eaton of Sustainable Carmel commented on Scott McKenzie's analysis report and suggested looking at two themes: 1) traditions and 2) good clean fun for youth and families. She thought that the current situation would be a problem for the individuals who first started beach fires for recreation and clean fun is only clean if everything is picked up from the beach. She thanked the ad hoc committee for their work so far.

Scott McKenzie thanked the ad hoc committee for meeting with him. He asked if we could preserve beach fires and have a clean beach, would we keep fires – yes. He suggested language for a defined problem statement. He also thought it would be a good thing to know the average amount of particulates that are released by an average fire.

Public comment closed 4:31 p.m.

Commissioner Ferlito wanted to know how much the City has spent on enforcement and cleanup to date. She also has noticed several volunteers helping with cleanup on the beach. She thought that perhaps the Committee should look at a fee for fire program as well as a non-fee program.

Commissioner Bang mentioned the question of fees will be one of the discussion points with the Coastal Commission.

Commissioner Ferlito pointed out that the current programs are subject to budget fluctuations while a fee system would not. She also noticed that many beaches do not allow alcohol or do not allow minors to get permits. Barbara Livingston said she was supportive of the report and likes the action the Commission is taking.

Commissioner Baron did not agree that the cost of beach fires should be born only by those that make them.

Commissioner Carter pointed out that traditions can change. Smoking for example used to be allowed almost everywhere, but today there are few places where smoking is allowed.

No further discussion.

4. Consideration of disbanding the ad hoc Beach Committee.

Vice Chair Refuerzo provided some background on the ad hoc Beach Committee.

Commissioner Ferlito asked if Commissioners should pass on their observations directly to staff.

Forester Branson agreed with that approach, particularly for items that need immediate attention.

Commissioner Ferlito asked if shoreline assessments will be completed this year.

Forester Branson noted that he structural assessment of the stairs will be starting very soon and other items are still pending.

Director Friedrichsen noted that the stairs and accessibility are the first priority and staff are looking for a consultnat to inspect the seawalls and revetments.

Commissioner Ferlito wants to know when they will be done.

Forester Branson suggested an agenda item to discuss the assessment issues.

Commissioner Bang asked for an agenda item for the next meeting to review an outline of the shoreline assessment plans for the year. She also noted that the ad hoc Beach Committee should be disbanded.

Public comment opened 4:51 p.m.

Greg D'Ambrosio noted that the Shoreline Plan has an assessment document within it and twice a year assessments of the easy to observe items should be done. Structural items that require an engineer should also be completed. He also thought the City should revise its service contracts.

Scott McKenzie advocated for measuring various aspects of the beach to quantify improvements and to compare to future years.

Public comments closed 4:57 p.m.

Commissioner BANG made a motion to disband the ad hoc Beach Committee; seconded by CARTER.

5. Discussion of the 2014 Arbor Day event and consideration of appointing an ad hoc committee.

Forester Branson reported he discussed with Steve Brooks from the Friends of Carmel Forest about combining an event with the FOCF October tree survey meeting. It was decided to keep the events as separate items.

Commissioner Ferlito suggested Dr. Lee Klinger as a guest speaker and perhaps the County Agricultural Commissioner's office to speak on sudden oak death. She recommended forming an ad hoc committee.

Vice-Chair Refuerzo thought an ad hoc committee would be helpful.

Commissioner Bang suggested an event on the City birthday on October 31st.

Forester Branson noted that the FOCF and perhaps other organizations would help with dispersing notices of the event.

Commissioner Ferlito worried about the short time to plan for the event. She pointed out that Dr. Klinger is available, but others may not be.

Commissioner Bang wondered if the ad hoc Committee could work on next year's event as well.

Forester Branson pointed out that, despite the short time left in the year, some event would be held this year to fulfill the Tree City USA requirement.



Vice-Chair Refuerzo suggested a tree giveaway.

Commissioner Ferlito noted that the FOCF will have their tree giveaway on November 8<sup>th</sup>. She offered to be on the ad hoc Committee.

Vice-Chair Refuerzo asked if Commissioner Baron would be on an ad hoc Committee.

Commissioner Baron answered affirmatively.

Vice-Chair Refuerzo appointed Commissioners Ferlito and Baron to an ad hoc Committee to plan a 2014 Arbor Day event.

#### 6. Forester's report

Forester Branson presented his reports and answered questions from the Commission. He also reported on the number of special event permits issued to AquaTerra over the last year. Flyers for the FOCF tree survey meeting were passed out to the Commission.

Director Friedrichsen reported on the sign consultant activities and reviewed the process for getting consultants under contract.

Vice-Chair Refuerzo suggested a continuing item for review of shoreline assessments and beach issues.

Commissioner Carter asked about sand profiles.

Forester Branson addressed his question.

#### 7. Public Services Director's comments.

Director Friedrichsen reported that the City Council received an update from Cal Am on the drought and using the City's Del Mar water. The Council also discussed the events of "car week" and the policies and practices for large events in the City.

Commissioner Ferlito asked when the review of the Mission Trail Nature Preserve Master Plan will be on an agenda and what is the best way to form a beach pathway committee.

Director Friedrichsen suggested an agenda item to discuss a pathway committee.

Forester Branson reported a new contract to remove 25 dead trees has been issued.

Vice-Chair Refuerzo asked about the status of working with the California Conservation Corps.

Director Friedrichsen addressed his question.



Vice-Chair Refuerzo asked about changing the November meeting time due to a scheduling conflict.

#### **Site Condition:**

This site is a 6,000 sq. ft. lot with a single-family home and attached garage. The lot slopes downward to the west from Camino Real St. The tree is located near the north property line about 10 feet from the side of the applicants house and about 8 feet from the home to the north. The canopy of the tree covers a large portion of the applicant's lot and the lot to the north.

#### Size and species of trees(s) requested for removal/pruning:

Remove one Monterey pine - 60" dbh.

#### Health and condition of tree requested for removal:

The Monterey pine is a large mature tree and appears to be in good overall health. The tree has a large spreading canopy comprised of many large limbs. There are several dead limbs within the canopy but the bulk of the limbs appear to be in good vigor and condition. The root collar has several large buttressing roots for support of the tree. No significant insect, disease or other structural problems were observed.

Recently, a limb broke from the tree and fell onto the home to the north. I was unable to inspect the portion that fell to determine a possible cause for the failure.

#### Previous requests and decisions:

None.

#### Reason for request - Description of Project:

The applicant considers the tree to be unsafe and a danger to her property as well as her neighboring properties. A recent limb failure which damaged a fence and the chimney of the home to the north has precipitated the application to remove the tree.



#### The importance of the tree(s) to the urban forest in the area:

The tree contributes to the upper canopy of the urban forest this neighborhood.

#### <u>Size and species of tree(s) that are to be preserved:</u>

Mayten - 4" dbh

#### Impacts construction may have on trees that are to be preserved and suggested mitigation:

N/A

#### Options:

- 1. Approve the application.
- 2. Do not approve the application.
- 3. Postpone consideration.

#### **Staff Recommendations:**

Option #2. Do not approve the application. The tree appears to be in good condition and health. The recent and past limb failures are unfortunate, but do not merit removal of the entire tree at the current time. The tree appears to have the potential to be a viable tree for some time.

I recommend that the tree be pruned to remove the dead limbs the tree and to reduce the weight of the some of the large limbs that extend over the two properties that lie beneath the tree. The tree should be monitored for any changes in its vigor and condition.

If the tree is allowed to be removed, I recommend planting two upper canopy trees on the property.





Dear Carmel Forest and Beach Commission,

As the owner of the property located at Camino Real 4 NW of Ocean Ave, I am requesting authorization to remove the large, dangerous Monterey Pine tree located in the back yard of my property.

This pine tree presents a clear and present danger to life and property and my neighbors and I are living in a state of constant fear because of it.

For the past 16 years I have tended and cared for the tree, keeping it trimmed and enjoying the beauty of it in our urban forest. However, everything changed on the night of August 30, 2014. As dinner guests were leaving my home around 9:30 P.M., we heard a horrendous cracking and popping sound that struck fear and panic in our hearts. We had no idea what was going on, but knew the sound was coming from the pine tree. It was pitch black and impossible to ascertain what was happening, but we knew it was a dangerous situation that required immediate action. As I scrambled to evacuate my houseguests, frantically call my immediate neighbors to warn them, and contact the fire department for assistance, I was in a state of panic. We had no idea of where to run for safety and we all feared that the entire tree was coming down. As the fire department arrived and shone a spotlight on the tree, a huge 30 ft limb broke free from the tree, crashing down and destroying my neighbor's chimney, damaging her roof and taking down our fence. The scariest part was that the huge branch just missed going through her bedroom window by less than 2 feet. It was a horrible event to witness. This was a warm night, no wind and no reason for this to happen except that the tree is old and past it's useful life. The branch that broke and fell looked healthy and viable and gave no visible sign of having problems.

This experience has left me in a state of continual fear, I can no longer feel safe in my beautiful home and I fear for the safety of my dear neighbors. I cannot be expected to live under these conditions.

As documented in the Journal of Arboriculture 20 (6) Nov., 1994, in the article "Patterns of Structural Failure in Monterey Pines" by Edberg, Berry and Costello, it is clear that the failure profile of the Monterey Pine tree is significantly greater than for other species, especially in relation to the greater frequency of branch failure. My tree is particularly at risk because of the advanced age, excessive height and large number of heavy pinecones located on the tapering branches.

I sincerely hope that the Beach and Forest Commission take into account the seriousness of this request and allow for the removal of this once healthy and beautiful tree whose useful life has passed. What remains now is the probability of damage to life and property and a neighborhood of extremely concerned residents who expect that the Carmel Forest and Beach Commission will honor the right of all citizens of our city to live in peace and safety.

I am a resident of Carmel-by-the-Sea and a neighbor of Linda Yellich, who lives directly across the street from me. As a 14 year resident of Carmel, and a former member of the Planning Commission, I appreciate the "town within a forest" nature of our community. The native trees in our community are one of the special characteristics that make Carmel, Carmel.

As one who appreciates the trees in our community, I am also vividly aware that we need to care for the trees as they begin to age and reach the end of their lives. The tremendous Monterey Pine that is in the rear yard of Linda Yellich, has reached the stage of decline, and needs care and attention. At this stage, that care and attention will require removal of the tree.

Linda has paid wonderful care for this Monterey Pine since she has lived on Camino Real, first by having it beautifully trimmed, and for the past 15 years, maintaining it. Her attention to the tree has allowed it to live gracefully for these past few years.

Unfortunately, the tree has now reached the end of its life. This has become apparent as I have watched its upper canopy from my second floor balcony and seen its progression to a mass of sticks and twigs, dropping pine cones and limbs onto Linda's home and her next door neighbor's home. Most recently, I was leaving her home late one evening and heard a dramatic popping sound. The unusual sound was not immediately recognizable. 




#### **Site Condition:**

This site is two 4,000 sq. ft. lots with single-family homes and a detached guest unit on the southern lot. Both lots are fairly level. The tree in question is located along the property line between the two homes with a portion of the trunk on each property. The basal swelling of the tree is in contact and pressing on the wall and foundation of the house on the southern lot and extends several feet out beyond the trunk into the northern lot. The canopy of the tree covers a large portion of both lots.

#### Size and species of trees(s) requested for removal/pruning:

Remove one coast redwood – 72" dbh.

#### Health and condition of tree requested for removal:

The coast redwood is a large mature tree and appears to be in good overall health. The main trunk divides into three 36" diameter, co-dominant stems about 20 feet above ground level. At the base of the tree there is a basal swelling or buttressing, that rises three feet above ground level and extends 4-6 feet outward from the main trunk. Basal swelling is common on coast redwood trees and is not a defect. The tree has a large spreading canopy divided among the three stems. No significant insect, disease or other structural problems were observed.

#### Previous requests and decisions:

None.

#### Reason for request - Description of Project:

The applicants are concerned about the current and future damage to the home on the southern lot and potential for damage to the northern property.

### The importance of the tree(s) to the urban forest in the area:

The tree contributes to the upper canopy of the urban forest this neighborhood.

### Size and species of tree(s) that are to be preserved:

Monterey pine - 36" dbh (southern lot)
Black acacia - 16" and 7" dbh (northern lot)

## Impacts construction may have on trees that are to be preserved and suggested mitigation:

# Options:

#### **Staff Recommendations:**

Option #1. Approve the application. Although the tree appears to be in good condition and health, the current level of damage to the southern property and potential future damage for both properties can only be alleviated by removing the tree or rebuilding a new home on the southern lot.

I recommend planting one new upper canopy on both lots and one new lower canopy tree on the southern lot.

Dear Mr. Kamm:

On August 6, 2014 I met with Sharon Swallow from Sotheby's International Realty to inspect the existing conditions of the house, especially as related to an existing Redwood Tree at the northeast corner of the house. I also looked at the foundation, cripple walls, and floor girders as related to the effects the Redwood tree has had on the structure.

The Redwood Tree has three large stems growing from a single root and trunk. The crown of root has been growing against the foundation and exterior wall of the house for many years. The house was constructed in 1929, and the tree certainly existed then. The growth of the Redwood Tree has displaced the house to the west (toward Santa Fe Street) approximately 3-inches. This movement has caused the cripple studs between the floor framing and foundation, and the posts supporting the floor girders to be out of plumb.

I am aware that you intend to add some anchor bolts and lateral bracing to the cripple walls of the house. It is apparent that the Redwood Tree must be removed before any bracing of the cripple walls and foundation could be reasonably accomplished. The Redwood Tree will continue to expand and further damage the house, even if the seismic retrofitting is completed. It is my recommendation that the Redwood Tree be completely removed prior to attempting any repairs to the foundation and structures supporting the floor.

# Dear Neighbors:

Hello, we are the property owners directly next door to your property on Santa Fe in Carmel. We are writing this letter to inform you of a critical issue regarding the redwood tree that grows in the middle of our shared property line. Having received the advice of multiple professionals we are advised that a trimming of the tree will not fix the issue of the trunk growing into our house (See Exhibits A,B,C and D). Also, the continued growth of roots into our house foundation has caused damage and in the future will cause damage to both of our properties. The tree needs to be cut down and removed. On July 23, 2014 we had a home inspection completed by American Inspection Service. It was recommended due to the size of the tree and its significant root system that we consult an Arborist who could make suggestions on trimming or possible removal of the tree. We then contacted Monterey Bay Engineers and their Structural Engineer, Steve Wilson who confirmed that growth of the trunk has pushed the structure of our house out of alignment and the continued growth and expansion of the roots has moved the foundation and will continue to cause movement. As you already know the root system of a large redwood covers a perimeter area around the tree and is most certainly affecting your driveway and possibly the foundation.

Who owns the tree? Under California Civil Code 834, if the trunk of a tree stands partly on the land of two adjoining landowners, then both landowners own the tree.1

"Tree Roots: although adjoining landowners have almost an unfettered right to trim encroaching limbs, branches and foliage, that is not the case with tree roots. If roots encroach under adjacent property, the property owner can sever the roots, but only if the roots are causing damage and only if done reasonably (perhaps by a professional). Then, the owner of the encroaching tree can be held liable for the actual out-of-pocket expenses incurred as a direct result of the tree's encroaching roots."2

The City of Carmel-By-The-Sea has a specific application permit process to remove trees. I spoke with Carmel City Forrester Mike Branson and explained the trees growth



into our house. He was very encouraging that a permit could be granted after the application is investigated based on the evidence. But, because we are both owners of the tree approval needs to be made on both parties submitting an application for the tree removal. I have sought appraisals from several local reputable Tree Removal companies that have the expertise and equipment that can remove the tree and trunk without causing any property damages.(licensed and insured). I will include copies of the tree and tree stump removal estimates. We especially need your approval as most of the equipment including a crane will require use of your driveway for at least 3-4 days.

We want you to know that we have researched this issue thoroughly and looked at all possible methods to solve the problem and save the tree. The tree and root system has cause significant damage to our respective properties and homes. To prevent further damage to both our properties we believe that now is the time to take steps to protect our properties. We want to remain good neighbors now and many years in the future. We are asking for the following items:

Item I; Application for Tree Removal to Carmel-By-The Sea. Signed and dated with application fee of \$32.51. Mail in to the City of Carmel.

Item II; Neighbors Agreement accepting 50% ownership of the tree and corresponding associated costs and liability for removal of the tree and tree stump. Signed and dated by you or your authorized Agent/representative.

Finally, time is of the essence to agree and move forward with the permit process. If we do not hear from you or your representatives by Friday at 5pm on Sept. 5, 2014 we will consider that as a negative response and will consider alternative legal remedies to protect our property. California State Law allows for treble damages as well as Attorney costs.
